

# Cooled, Shipped Semen Contract

1. The fee schedule will be as follows:

a. The fee of \$250.00 will include the collection and processing of one semen shipment. The fee includes the semen collection and processing, semen extender and equitainer rental. The Federal Express charge (varies with speed and distance) or airline charge of \$250 will also be the mare owners responsibility. Unsuccessful semen collection attempts will be \$100.00 each.

b. When shipping with the airlines the fee does not include delivery of the shipment to the address provided. Pickup of the package at the airport and delivery is the responsibility of the Mare Owner.

2. Refunds will be given as follows:

a. If Federal Express delivery is late and the mare owner requests a refund for the shipping charges the mare owner must notify Jan Martin Equine Management (JMEM) within 24 hours. If Federal Express issues a refund for the shipping charges this will be refunded to the mare owner.

b. Each package sent with Federal Express will be insured for \$400.00. If Federal Express issues a refund of the insured value the mare owner will be credited the refunded value not to exceed \$400.00. If you request a higher value this will need to be discussed prior to shipment. This \$400.00 is refundable only if the package is lost or damaged or if the semen has deteriorated due to late delivery. This is an evaluation you or your veterinarian will need to make. The mare owner will be responsible for sending a written statement to Federal Express and pursuing the claim.

3. The mare owner understands that deliveries are not guaranteed and agrees with the service conditions, Declared Value and Limit of Liability of any courier service appointed by JMEM which includes but is not limited to Federal Express, UPS, United Airlines, AmericanAirways, Perry's Parcel and JMEM.

4. The Mare Owner agrees that each requested shipment will be sent with Federal Express unless directed otherwise. If an overnight courier other than Federal Express is requested there will be a \$50.00 charge.

5. When a shipment is requested to be sent with the airlines, JMEM will chose the airline and flight which will accommodate the shipment best and confirm it is satisfactory with the recipient.

6. Payment of the fee will be prepaid by check or credit card before the package is shipped out. Mare Owner agrees that with each shipment request their check or credit card will be deposited or credit card charged the appropriate fees for services rendered on the day of collection. These collection and processing fees are non-refundable other than what is discussed in item 2.

7. JMEM must be notified 24 hours in advance of collection time. Same day requests will be charged an additional \$100.00.

8. The Equitainer parts sent with the equitainer must be returned with it otherwise the credit card will be charged for replacement.

9. The Equitainer must be returned within three business days of its delivery to Jan Martin, Rancho Jonata, 1301 McMurray Road, Buellton, CA 93427 or a \$50.00 per day charge will be billed to the credit card or account.

10. JMEM does not guarantee the fertility of any stallion but agrees to process each ejaculate so as to optimize 24 hour post cool motility and subsequent fertility.
